The Supreme Court of the Virgin Islands wishes to announce that it will convene its Eighth Session of the 2015 Term on Tuesday, October 13, 2015, at the Court's facilities at No. 161B Crown Bay, St. Thomas, U.S. Virgin Islands.

Oral Arguments will commence at 10:00 a.m. in the following cases:
